2. The Entity invites sealed bids/Proposals from eligible surveyors for the provision of the above services.

3. Bidding will be conducted in accordance with the **Open Domestic Bidding** method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and Regulations as amended in 2014 and is open to all bidders.

All bids must be accompanied with a bid security of **Ugx:10,000,000 (Uganda Shillings Ten Million Only) in form of a Bank Guarantee**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(a) at **11:30AM on 8<sup>th</sup> October, 2020**
