

BID NOTICE UNDER OPEN BIDDING

1. The **Ministry of Tourism, Wildlife and Antiquities** has allocated funds to be used for the **Provision Of Non Consultancy Services To Carry Out Cadastral Survey Of 40 Cultural Heritage Sites (MoTWA/Non Cons Srvc/21-22/00075)**
2. The Entity invites sealed bids/Proposals from eligible surveyors for the provision of the above services.
3. Bidding will be conducted in accordance with the **Open Domestic Bidding** method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and Regulations as amended in 2014 and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **08:00am to 05:00Pm.**
5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(a) and upon payment of a non-refundable fee of **Ugx:100,000 (Uganda Shillings One Hundred Thousand Only)**. The method of payment will be by using a bank payment advice form and depositing the money on the GoU/URA Consolidated Bank Account.
6. Bids must be delivered to the address below at 8(a) at or before **11:00AM on 28th December,2021**. All bids must be accompanied with a bid security of **Ugx:20,000,000 (Uganda Shillings Twenty Million Only) from a Bank** . Bid securities must be valid until **4th April 2022**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(a) at **11:30AM on 28th December,2021**
